- 13 Mr. Eaton made a motion to approve the public and non-public minutes from 11-29-21 and
- 14 12-6-21 as written. Ms. Danis seconded. Unanimously approved by a vote of 5-0.
- 15 Mr. Dumas made a motion to approve the public and non-public minutes from 12-6-21 as
- written. Mr. Morin seconded. Unanimously approved by a vote of 5-0.

- 18 Budget Committee
- 19 Ms. Danis said there were some minor questions for the town budget. The overall sentiment was
- 20 positive.
- 21 Planning Board
- 22 Mr. Morin said they had a preliminary discussion for a 26-house development on Smoke Street.
- There were questions about the aquifer and having the development close to Fort Hill Road.
- 24 There was a two-lot subdivision on Gebig Road which was approved. A subdivision off Kennard
- 25 Road was approved. Lamprey River subdivision will be discussed further at an upcoming
- 26 meeting.
- 27 *CIP*
- 28 They went over the draft spreadsheets.
- 29 *300th Celebration Committee*
- 30 Ms. Danis asked when this committee were coming in to BOS. January 8 is the bonfire.
- 31 Marston Property

- 32 Ms. Danis said a shed has arrived.
- **Town Administrator Report**
- 34 There was no update.
- 35 Action Items from Last Meetings
- 36 PLIA funding, tax rate setting, year-end surplus
- 37 12/13: Shawn McLean, Recreation Department, fire department/Cove Road
- 38 2022: road standards
- 39 Mr. Bartlett asked what the decision is on Cove Road. Mr. McLean said they are not plowing or
- 40 maintaining it. Mr. Morin said they have graveled that road in the past 15 years when there was a
- washout and the road had major ruts. Mr. Bartlett asked the BOS what the general consensus is.
- 42 Mr. Dumas said if they do anything on that section, the section of that road should be made an
- EL. If not, he doesn't believe they should do anything. Mr. Bartlett said the steepness prevents
- 44 the town vehicles from going on that portion of the road. Mr. Morin said he would like to gravel
- 45 and not do anything else. Mr. Eaton agrees, and Ms. Danis does as well. Mr. Dumas said he is
- 46 not opposed to doing anything but wants to stick to the letter of the law. Mr. Bartlett asked if the
- 47 fire chief had a preference. It's not known if he does. Mr. Morin said they should keep it to
- passable and it does not need to be plowed. Mr. Dumas said the town is using this road for a
- 49 given purpose. Ms. Danis said they need to be consistent with the roads; there is a sign that it is
- 50 used by the fire department as a launch so she feels this road is different than some of the others.
- 51 Mr. Bartlett would go with Mr. McLean's decision of doing nothing additional.
- Mr. Eaton said if there was a gravel drop 15 year ago, maybe it's time for one more.
- Mr. Morin said the road is very rough. Mr. McLean said he was on this road; the fire dept. would
- 54 get down there with a 4-wheel truck. The snowplow truck would not be able to drive down there
- 55 and turn around.
- Mr. Dumas said he would like to stick to the letter of the law.
- 57 Mr. Morin made a motion for a gravel drop to the portion of Cove Road that is in question to
- 58 keep it passable with no plowing. He rescinded.
- Ms. Danis made a motion to authorize the highway department to conduct a one-time
- gravel drop on the launch end of Cove Road to ensure possibility for fire department use,
- 61 the extent to which will be determined by the Public Works Department. Mr. Morin
- seconded. Unanimously approved by a vote of 4-1 with Mr. Dumas abstaining.
- Ms. Danis said the lake host program would like the operating piece of the PLIA budget to be in
- the town budget and the reserve fund will be dedicated for emergency funds. This would be a
- 65 net increase. Ms. Danis said they need to have a bigger discussion about this in conjunction with
- the rest of the budget.

- The tax rate has been set.
- The BOS will support putting the Conservation Commission warrant article on the ballot.
- 69 Assessing
- 70 Mr. Dumas made a motion to approve the intent to cut for Map 46 Lot 6. Mr. Eaton
- seconded. Unanimously approved by a vote of 5-0.
- 72 General Business
- 73 2022 Budget
- Ms. Danis said they invited the recreation department and Public Works to go over their
- 75 department budgets.
- Mr. McLean said they are asking for replacement of a truck and old police car with two trucks.
- 77 There are high-cost issues with these vehicles that will be coming soon. Ms. Danis asked how
- 78 much would come out of the highway truck fund. Mr. McLean said both vehicles would come
- out of the funds and there would be an ask for \$100k each to be put back into each reserve fund.
- Mr. Bartlett said in 2018 there was a proposal for a 1-ton dump truck. He said he had suggested a
- 550 truck at the time. Mr. Bartlett asked Mr. McLean asked if he would be amenable for a 550-
- 82 utility body truck and come back next year to ask for the other one. Mr. McLean said no; he is
- replacing the car and truck. He said he doesn't need the 550 truck. Mr. Bartlett said the 350 truck
- is in very bad shape and the 550 truck would hold up better.
- Mr. Morin asked if there were 5 employees and said there are more trucks than employees. Mr.
- 86 McLean said it is necessary in the winter.
- Mr. Bartlett said he doesn't think a 1 ton will withstand the weight and abuse. He believes the
- 550 truck would hold up better. Mr. McLean said they can hold more in the 550 truck. Mr.
- McLean said it could take less time to plow. Ms. Danis said they don't need a 550 truck to plow
- 90 the town and school but if it will help with the dirt roads and save money, then it would make
- 91 sense. Mr. Eaton asked if they really need any equipment. Mr. Bartlett said they do have more
- vehicles than employees. Mr. Bartlett said that the 350 trucks is on its last legs; he doesn't want
- 93 to replace it with another. He believes the 550 truck would be the better choice and the
- 94 department would get more life out of the truck. Mr. McLean said it may last longer as it is made
- out of aluminum. The 350 trucks are also aluminum bodies but Mr. Bartlett said the suspension
- 96 systems are different.
- 97 Mr. McLean said there are 4 dump trucks, 350 truck, the car and the 1 ton. The 350 and the 550
- are used to plow. They have different vehicles for different jobs.
- 99 Mr. Bartlett said they have contractors as well; he doesn't think they need two new vehicles. Mr.
- Bartlett said asking for 2 vehicles is not very wise. He would support a 550 truck although the
- 101 cost has not been reduced at all. There is not enough employees. Ms. Danis said you are asking

- for the same amount of money. Mr. Bartlett said the two trucks would be a maintenance
- nightmare rather than one higher model truck.
- Mr. Dumas said he can't make a recommendation one way or the other. Mr. Morin said he would
- be in favor of replacing the one 350 truck with the same truck. Mr. Eaton said he will have to
- think more about this.
- Mr. McLean said he would be okay with getting one 350 truck only.
- Mr. Bartlett said he would not support this as you are wasting money and he is speaking from
- experience. Ms. Danis said if the department head is comfortable with this solution, then she is
- 110 comfortable. Mr. Morin said he doesn't want to go above and beyond and spend more money.
- Mr. Bartlett said the maintenance is high because there isn't enough maintenance being done on
- the vehicles. The vehicles need to be more properly washed. There have been issues with the 550
- truck as well. Mr. Eaton said the life of these trucks should be longer.
- Mr. Morin made a motion to put a 350 truck in the budget to replace the other 350 truck.
- Ms. Danis said there may not be a need for a motion. They need to decide what they are putting
- on the warrant articles. Mr. Dumas said they are trying to cut the budget and Mr. McLean is
- willing to go forward with 1 truck instead of 2. Mr. Morin rescinded motion.
- Mr. McLean said the 350 truck would be gas instead of diesel. Mr. Bartlett said that type of truck
- is a gas guzzler. Mr. Dumas and Ms. Danis said it is fair compromise. Mr. Morin said the
- consensus of the Board is go forward with one 350 truck.
- Ms. Danis said the cost of commodities is a guess. The big ask is for the shared personnel
- resource between public works, recycling and recreation; she asked if they really need that this
- 123 year. Mr. McLean said they need someone to fill in at recycling center as well as at rec. dept. and
- highway dept. Ms. Duball said they have been talking this past year about the need for this
- position and the two departments work well together. The rec. dept. can't do the things that need
- to be done at Marston property. People aren't volunteering for items that the highway department
- does for the rec. dept. It would be ideal to have this shared position to help out between the
- departments. Ms. Duball said they will have to make it work if they don't get this person. The
- irrigation has not been put in the Marston; they need to have trash cans and porto potties. The
- rec. dept. will continue to have flag football there. Marston property needs to be mowed. Ms.
- Danis said the fundraising is covering the back stops. Mowing is contracted out through an RFP
- for all properties. Ms. Duball and Mr. McLean said they would make it work if the person was
- Total properties. This business are the person was
- not put in the budget and they could come back with the ask next year. Mr. Morin asked if this
- person would be plowing; Mr. McLean said yes. Mr. Eaton said in Raymond the coaches don't
- do anything except coach; the town takes care of the baseball fields. He doesn't see the need for
- the person as the volunteers will continue to take care of the fields.
- Mr. Dumas said they have worked hard to pass budget at or below inflation in previous years.
- 138 They have taken on a lot of new things: Marston and new roads; at some point, they have to pay

- the piper. Mr. Dumas said the ability to keep the budget with low increases is going to get less
- and less. He said with no new positions, the rate is still an increase of 7%. Ms. Danis asked what
- percentage are they comfortable presenting to the town. Mr. Dumas said the roads and Marston
- drove up the costs. Mr. Eaton suggested letting the town vote on these positions. He said the
- property has been sold on Rte. 4. Ms. Danis would be opposed to putting the new employees out
- as a warrant article as it becomes a precedence. Mr. Dumas said it's not realistic to get the budget
- 145 down to 3-4%.
- Ms. Duvall said she would go without the beach gate keeper. It will be a position that will be
- hard to fill in the future; the person who does it now will likely continue for another year.
- 148 Chief Vilchock distributed metrics to the BOS. He is striving for 24-hour operations. The
- lieutenant would be the 2nd in command. There is a deputy chief as well. There is an ask for a 2nd
- ambulance as a warrant article. It would be fully funded from the reserve fund. There is a trust
- 151 fund left to the fire department that can be used for rescue type of equipment. This money will
- outfit the ambulance. It has been a goal of the fire chief to have 24 hour operations within 10
- years; he is at the 15 year mark.
- Ms. Danis asked about grants for bringing on staff. Chief Vilchock said there is a SAFER grant
- but it's given to bigger towns.
- 156 Chief Vilchock feels he will have a better opportunity to keep current employees and hire others
- with the 24-hour operation. The positions would be filled in September. He'd like to leave it up
- to the town to decide what level of operation they want for fire department.
- Ms. Danis does not feel it's the right time to add staff. Mr. Dumas said it will affect his schedule
- model and the chief may lose people. Mr. Morin said that people don't volunteer. He said we are
- the only town in the area not doing 24-hour service. They are going to have raise the town
- budget percentage at some point after having low percentages for many years. Ms. Danis asked if
- the Board feels like they can defend any percentages. Mr. Bartlett said 10% increase is not what
- he wants. Ms. Danis suggested coming up with recommended item cuts for next week's meeting.
- Mr. Morin suggested 8% increase with full time fire department, full time person for the
- recycling/rec. dept/highway dept. Mr. Eaton would like to know what the state funds will pay
- for. He said that there is a larger portion of people over the age of 55.
- An additional meeting will be held at 9am on 12-18. Mr. Morin won't be at meeting, but the rest
- of the BOS will be.
- 170 Debt Reduction
- Mr. Dumas said he is in favor of paying off fire department and Mulligan Forest with the sale of
- Rte. 4 proceeds or fund balance. Ms. Danis agrees. Mr. Bartlett, Mr. Dumas are in favor of
- putting this forward as a warrant article. Mr. Morin said on these loans, the interest rate is very
- low. Mr. Dumas said it's still \$70k in interest. Mr. Morin asked if they will have enough money
- for the other items they want to use money for. Mr. Dumas said that it is the tax money that the
- town was deprived of from the Rte. 4 property for many years. They should do something with

- that now to help the town. Mr. Bartlett thinks that Conservation Commission should pay off the
- Mulligan Forest. Mr. Morin said the 10% is still going to Conservation Commission. Mr. Bartlett
- said he would like to pay down the debt. He would like to use Rte. 4 property proceeds to pay off
- the fire department and Mulligan property. It will go forward as a warrant article. The Board
- 181 concurred.
- 182 *Policy*
- There was a discussion about the Town of Nottingham COVID-19 policy that was recently
- created. Mr. Dumas said it's a practical policy and not too demanding. Mr. Bartlett said it seems
- to be within the CDC guidelines. Ms. Danis said it will require mask wearing for everyone. Mr.
- Bartlett said he is not in favor of wearing masks all the time. Mr. Morin whether they require
- mask wearing should be evaluated monthly. Mr. Morin said the general public should be wearing
- masks when people come in the community center but those workers who are at their desks
- shouldn't have to wear masks. Mr. Dumas said this policy goes beyond the measures that was
- posted this morning. Mr. Eaton said lawsuits could be made against Nottingham if people
- develop COVID-19. Mr. Bartlett asked how far they want to go if someone will not wear a mask.
- Mr. Dumas said if people insist on defiance, they are trespassing. Mr. Morin said the workers
- don't have to provide service to those who are not following rules.
- Ms. Danis made a motion that the Select Board adopt the COVID-19 policy discussed on
- December 13 with the change to the last line of the first paragraph to read "The purpose of
- this policy is to ensure the health and safety of town employees, resident, elected officials,
- volunteers, and all others who enter Town building facilities." Mr. Dumas seconded.
- 198 Unanimously approved by a vote of 5-0.

- Mr. Reed asked why the conservation land can't be paid off from Conservation Commission. Mr.
- Dumas said the Conservation Commission would have to approve that. Ms. Danis said that it is
- the other way around. Mr. Dumas said the BOS has to do it with the conjunction with the
- 204 Conservation Commission. It has to start with the Conservation Commission. Mr. Reed asked if
- 205 it is worth asking the Conservation Commission. Mr. Reed said he would like the BOS to ask
- 206 them.
- Mr. Reed asked for the meeting packet for the BOS. Mr. Bartlett said events have occurred in the
- past few days that didn't allow the BOS to present the packet in a timely fashion. Mr. Reed
- 209 understands that personnel info can be redacted and would have liked the budget information to
- follow along in the meeting. Ms. Danis gave Mr. Reed a copy of the budget. Ms. Danis said they
- 211 haven't provided materials to the public before. She asked Mr. Reed if he would like to receive
- packets all the time. Mr. Reed said if he requests them. Ms. Dallaire will release the packet from
- 213 this meeting to Mr. Reed.
- 214 Mr. Reed asked about adjusting the elderly exemption.

There was further discussion about trucks for the highway department.
