23 General Business

- 24 Old Town Hall Renovations
- 25 Mr. Sylvia is the point person for the old town hall renovations. Any renovations need to be
- under contract by year end. Mr. Sylvia is looking for a conceptual approval from the BOS
- tonight. Several things were evaluated for this project: cost, cost vs. benefit, operations for the
- school and how well it would work long-term. The initial plan was to demo the bathrooms and
- 29 put in a kitchen and make a new bathroom however, heating the hall and insulating it didn't
- 30 make sense. Another option included jack hammering the ledge which didn't make sense. They

- are proposing a space between two buildings and make that part of the living space and adding a
- 32 small addition. The kitchenette could be used by residents as well. The existing bathroom would
- be remodeled. It will give the school more space than they asked for, it will require the least
- change and the town have access to the kitchenette and new bathroom. Ms. Danis asked about
- the 2nd floor. Mr. Sylvia said the 2nd floor is off limits and two windows will be lost on the 2nd
 floor due to this remodel. The town will still have access to the 2nd floor but it's not usable at this
- 37 time. A portion of the upstairs would be better protected as they are using spray foam in the
- building. Mr. Sterndale said there is no egress on the 2nd floor and the windows are very low. It's
- not safe to be up there. Mr. Sylvia said there is a big heavy safe built into the wall. It's over the
- 40 main hall.
- 41 Mr. Sylvia said because of the limited time frame, the BOS needs to approve the conceptual
- 42 design tonight. There will not be enough time otherwise to use the year-end funds. Mr. Sylvia
- 43 will come to the BOS next week with the bidders.
- Ms. Danis said the school needs a place for the SAU in addition to the BOS using the end of theyear funds.
- 46 Mr. Sylvia said the bid process is still open so he is not able to speak in public about financials.
- 47 Mr. Morin and Ms. Danis said this seems straight forward.
- 48 Mr. Sylvia said that there is no difference on the front side of the building. Ms. Danis asked if
- 49 there is any historical designation. Mr. Sterndale said no, however the Historical Society looked
- 50 at the proposal and they are fine with this. They want to preserve the look of the building from
- 51 the front, and they want to preserve the space.
- 52 Mr. Sylvia said it will have a sink, fridge, and microwave. There will be no stove. There is no
- 53 heat in the building right now; the duct work will remain. A boiler could be added in the future.
- 54 The back room of the building needs to be cleared out for a fire egress. They are losing an egress
- 55 with this proposal, but they are creating another.
- 56 The BOS concurred that they would like Mr. Sylvia to move forward with getting bids for the
- 57 RFP for the old town hall.
- 58 Mr. Sylvia said for the renovations for the kitchen at the community center; the costs are \$10k
- higher than the warrant article proposal. Mr. Sterndale said they could use unspent funds for theoverage.
- 61 Ms. Danis said would like to move forward with the renovations for the kitchen at the
- 62 community center.
- 63 The Board thanked Mr. Sylvia for taking these projects on.
- 64 Mr. Sterndale passed out year-end budget projections. He believes there will be \$185K surplus.
- 65 The BOS can use it for any appropriations that apply.

- 66 Mr. Morin said the tasers and training for the police department would pass in a warrant article.
- 67 Ms. Danis thinks that dashboard cameras for the police department would pass for a warrant
- article as well. Mr. Morin said they could pay for the dashboard cameras with the year-end
- 69 money. Ms. Danis said some of the BC were surprised that the police department didn't have
- 70 tasers already. There was further discussion on what to put for a warrant article and what to pay
- for with the year-end money for the police department. Ms. Danis said the chief said the
 dashboard cameras show more than the body cameras. Ms. Danis said once they know the
- ⁷² dashboard cameras show more than the body cameras. Mis. Dams said once they know the
- raging surplus, they can figure out what to spend.
- 74 Mr. Morin asked about Case Road. Mr. Sterndale said they are looking to overlay some of the
- road. They proposed more than they used for asphalt. They would have spent the money on Case
- Road. It's high on the list but the old town hall renovation takes precedence. Ms. Danis said
- when they say paving a road, they really mean overlay and that the overlay protects the roads.
- 78 Other

79 The deliberative session date needs to be set. Ms. Danis said that people didn't like attending the

- town meeting on Saturday so perhaps having the deliberative on a weekday would be optimal.
- The school is doing theirs on the Feb. 8. Mr. Morin said he believes the town can do theirs on a
- 82 weeknight as well. Mr. Dumas said they could do Saturday Feb. 5. Mr. Morin said he can do any
- 83 day of the week. Mr. Sterndale said the moderator is indifferent on the day but would like to use
- 84 the school. Mr. Morin asked if they could use the gymnasium at the community hall. Mr.
- 85 Sterndale said yes but the moderator prefers the ventilation of the school. Ms. Danis said it
- 86 would be 2 nights during the week if the town does there on a weeknight as well as the school.
- 87 Mr. Morin said they can do Sat. Feb. 5. The BOS decided to have the deliberative session on 2/5
- at 9am and the backup will be 2/12. It will be held at the school if available.
- 89 2022 Budget
- Mr. Morin said the highway department has a lot of upgrades. Ms. Danis said it's driven by the 90 salt and the newly acquired roads. Mr. Sterndale said it's also the new personnel. Ms. Danis said 91 92 she asked for the budget without the new employees added in. Mr. Sterndale said the engineering 93 costs are eligible for ARPA. Ms. Danis said they may need to cut \$400k out of this budget to get 94 to less than 2%. Mr. Morin would like to reduce the budget by a few percentage points. Ms. 95 Danis said they should invite Shawn McLean to the meeting to discuss the budget and the 96 warrant articles. Also, he could be at the meeting for the road standards discussion. Mr. Morin suggested discussing the roads standards in the new year. Mr. Dumas said he doesn't see the 97 Board discussing the road standards for the rest of this year due to time. Shawn McLean will 98 99 come into a meeting this year to discuss the budget only. Mr. Morin suggested some cuts to the
- 100 recreation department.

101 Mr. Dumas made a motion to approve the reappointment of Debbie Ricker of an alternate

for the Library of the Trustees. Mr. Danis seconded. Unanimously approved by a vote of 3 0.

- 104 The Board concurred that the BOS would put the warrant article that the Conservation
- 105 Commission proposed on the ballot.

106 Mr. Morin said the residents on a certain portion of Cove Road will take care of the plowing on

- this part of road if the town puts a bit of gravel on the road. Mr. Morin said the road becomes a V
- and all of it is considered Cove Road. Mr. Dumas said this would be a perfect instance of an EL
 since the fire department uses it. Ms. Danis said she agrees with putting down some gravel on
- since the fire department uses it. Ms. Danis said she agrees with putting down some gravel onthis section of the road especially since the fire department uses this part of the road. Mr. Dumas
- said he thinks they need to label the road correctly and he is comfortable with putting gravel
- down. He would not feel comfortable putting gravel down and then not plowing. Mr. Morin said
- 113 the town may not be able to turn around for plowing and one of the residents can plow it. Mr.
- 114 Sterndale said they should speak to the fire department on how they use the road. Mr. Sterndale
- said they can't spend town money on private property and as it stands right now, it's private
- property. The resident is asking the BOS to overturn what Mr. Sterndale said. Ms. Danis said
- there is a fire department sign saying the fire dept. uses it.

118 Mr. Dumas asked what happens to a road like Cove Road for the E911. Mr. Sterndale said in

119 order to be a road and not a shared driveway, it has to have more than three houses.
