# <u>PLAINTIFFS' ASSENTED-TO MOTION</u> TO CONTINUE 6/28/20 CLASS CERTIFICATION HEARING

NOW COME, the Plaintiffs, Pamela D. Kelly ("Petitioner Kelly"), Matthew H. Eaton, Kevin E. Jordan, Jerome F. Lapham, Jr., James P. Rosborough, Peter W. Lyle, Michael Herron, Amede A. Baillargeon, Jr., Shane Carey, and Roger Frieden, Cheryl Leblanc, Thomas Duffy, John Does #1 through #5, and Jane Does #1 through #5, by and through their attorneys, Alfano Law Office, PLLC, and file this Assented-To Motion, stating as follows:

- The above-captioned Plaintiffs initiated the present action, seeking to obtain a decision of
  the legal classification of certain "Camp Roads" located in Nottingham, NH and to
  resolve the lack of clarity and recurring disputes over the Town's responsibilities to same
  roads.
- 2. On or about August 24, 2020, the Defendant filed a Motion to Strike Class Action.
- 3. Thereafter, this Court held a conference with counsel-of-record and, by Clerk's Notice dated February 9, 2021, the Court scheduled a hearing for Monday, June 28, 2021, for the certification of the class of plaintiffs.

- 4. On Tuesday, June 8, 2021, the Town of Nottingham held its Town Election Day and residents voted in favor of Warrant Article #19 which accepted seventeen (17) of the Camp Roads listed in paragraph 43 of the Complaint.
- 5. At the Town Meeting, earlier in 2020, the residents voted on a warrant article that accepted Highland Road as a class V highway and at the June 8, 2021 Town Election Day, Nottingham residents voted in favor for Article #19, for accepting the 17 Camp Roads as "town roads".
- 6. Thereby, the eighteen (18) Camp Roads in the Complaint are now town roads, or Class V roads.
- 7. The Plaintiffs likely will need to amend the Complaint to remove same approved Camp Roads from this lawsuit.
- 8. Further, the Plaintiffs need time to assess the impact of the passage of the Camp Roads

  Article on this lawsuit, assess their options, and for the entire class of Plaintiffs to decide

  upon the course of action to be taken as to this action, all of which cannot be

  accomplished prior to the June 28<sup>th</sup> class certification hearing.
- 9. The Town assents to the requested relief.

WHEREFORE, the Plaintiffs respectfully request that this Honorable Court:

- A. Grant the foregoing Assented-To Motion to Continue;
- B. Issue an Order continuing the June 28, 2021 class certification hearing for ninety (90) days;
- C. Grant such other and further relief as may be required.
